

Our library joined the Law Library of Congress in November as part of their webinar series, Orientation to Law Library Collections. It was a great opportunity to reach people throughout the country and share information about our library's collection. The Wisconsin State Law Library originated in 1836 and is almost as old as the Library of Congress!


The David T. Prosser Jr. Library welcomed 393 new attorneys for the signing of the roll book of the Wisconsin Supreme Court. We enjoyed connecting with new attorneys at signing events throughout the year.

In 2023, we expanded upon our webinar and in-person training. Our librarians presented 22 hours of education in 19 unique presentations. We also offered tours and meeting space to agencies within each branch of government.

Self-represented litigants from all over Wisconsin continued to receive help from our librarians by phone and email. Our branch library staff in the Milwaukee and Dane County courthouses provided access to court forms and information in partnership with court offices and legal assistance clinics. In 2023, Dane County Law Library coordinated with the City of Madison to translate its Low Cost Legal Assistance Guide to Spanish, Hmong, and Chinese.

Supporting the work of the Wisconsin Court System is the State Law Library's highest priority. Judges and court staff throughout the state rely on our libraries for research help, authoritative sources, and continuing legal education. 

The Court's Library



The Wisconsin State Law Library is part of the Wisconsin Court System, and serves the Wisconsin Supreme Court, Court of Appeals, and judges and court staff throughout the state.

Welcoming appellate law clerks to the library is an annual tradition at the start of the judicial term. Through law clerk orientation and new employee tours, librarians connect with new court colleagues and showcase the print collection as well as the many electronic resources the library provides. The library's Rare Book Room is always a highlight of the walking tour and serves as a reminder of the long-standing role the library holds in the court's history.

Library Collections

The Library hosts the current Wisconsin Jury Instructions on its website. Librarians collaborate with the Office of Judicial Education to coordinate and share information on jury instructions, which are created and edited by the Wisconsin Jury Instructions Committees of the Wisconsin Judicial Conference.



The three titles include +1,500 individual instructions.

The library facilitates the ordering and distribution of Wisconsin titles for the Supreme Court, Court of Appeals, Dane and Milwaukee County law libraries and chambers, the Prosser Library, and court departments.



The library selects, orders, and processes books which are delivered on a weekly basis to the Supreme Court chambers, Court of Appeals districts, and Dane and Milwaukee County courthouses.

Archiving materials of significance to Wisconsin judicial, legislative, and regulatory research is an important objective of the State Law Library. The library maintains collections such as session laws and statutes dating back to the Wisconsin territory, drafting files, the Judicial Council Collection, Supreme Court rules, and appellate briefs dating back to 1839.

The Court's Library

In addition to our staffed library hours, Supreme Court and Court of Appeals employees have full access to the David T. Prosser Jr. library before and after the building opens and closes, and on weekends or state holidays. Our After Hours service allows the Court to continue researching, and even check out books while the library is closed.

When the library collection doesn't have a book or article, our Interlibrary Loan service tracks it and requests it from another library, saving time and money for court staff. Interlibrary loan processes were streamlined this year, shortening response time in half.





Newsletters

The library publishes bulletins for the Supreme Court and Court of Appeals, with insights into services, research tips, and library events. WSLL @ Your Service, the library's monthly newsletter, goes out to readers across the state and nation. Extensive archives on the library's website provide readers with instant access to librarian-authored articles.

Helping Self-Represented Litigants


Our libraries help self-represented individuals and others to navigate the court system and legal assistance services in their area. We help people at our public service desks in Madison and Milwaukee, and many others over the phone or email. Access to technology, including the internet, computers, and printers, is an important part of supporting access to justice in Wisconsin. Our library staff brings in-depth knowledge of state and local resources, and a talent for listening to people in need throughout Wisconsin.

Law Day The Dane County Law Library (DCLL) participated in Law Day events in May. DCLL hosted free legal consultations. Several dozen visitors attended and received legal guidance from local attorneys and retired judges.

Language Accessibility DCLL broadened the availability of Spanish language forms at the library while requesting translation of additional high demand state court forms. DCLL coordinated with the City of Madison to translate the existing Low Cost Legal Assistance Guide into Spanish, Hmong, and Chinese.

Librarians as Educators

From impromptu computer support to formal CLE instruction, our librarians consistently fill the role of "educator" for judges and court staff, attorneys, and pro se users. The library's free CLE program includes a series of classes that focus on reading Wisconsin legislation and accessing and interpreting sources of information originating in the legislative branch – often referred to as statutory or legislative history research. This program has expanded from just one class on legislative drafting files to a series of several installments, covering basic understanding, advanced research, and special problems.

Does my personal representative need to be bonded?

How hot is "too hot" for working conditions? Librarians don't have all the answers but we know where to look. Searching is often what librarians enjoy doing best. As a library that serves an entire state (and beyond), we recognize that most users cannot trek to the library to find information.

How do I search property records?

How do I look up a registered agent? In addition, many users are not familiar with navigating legal research systems. Reference librarians often serve as proxies for our users. We take a question and, using years of experience and honed skills, venture into the stacks or databases to see what we can find. Librarians find answers in books, articles, cases, statutes, and codes. These results are delivered to the user for review.







Circulation


Top 10 Circulating Titles

Partnerships

Dane County Jail

Under a contract with the Dane County Sheriff's Office, the library responds to requests for legal materials from jail residents.

County Legal Clinics

The branch libraries collaborate with clinics in both courthouses to provide excellent assistance to litigants. The Dane County Law Library helps to coordinate clinics and provides space for clinics to meet in the library. The Milwaukee County Law Library partners with the Milwaukee Justice Center to provide information to self-represented litigants. The State Law Library also maintains a directory of legal assistance clinics and resources for all 72 counties on its website.

Office of Judicial Education and Jury Instructions

The Office of Judicial Education provides education for judges and Clerks of Court throughout Wisconsin. State Law Library staff regularly collaborate with the Office of Judicial Education to coordinate and share information on Wisconsin Jury Instructions.

The Library hosts the Wisconsin Jury Instructions on its website, wilawlibrary.gov. Instructions are used to assist judges and lawyers in providing instructions to jurors who must reach verdicts during trials. Library staff work closely with the jury instruction reporter to load new releases and other updates to the website.

Madison Paralegal Program

The Library has a long-standing partnership with the Madison College Paralegal Program. Librarians are part of the Program's Advisory Board and the Library's collection serves as a resource for faculty and staff. Libraries often host paralegal student interns fulfilling their practicum assignments.

Wisconsin Digital Archive

The library participates in the Wisconsin Digital Archives collection, a cooperative project with state agency librarians to archive and catalog state government publications. Staff catalog publications relevant to the Wisconsin Court System, Wisconsin Department of Justice, and other materials beneficial to our researchers.

Wisconsin Judicial Council

The library hosts and maintains the website for the Wisconsin Judicial Council, and stores records for the Council alongside its historical collection of Wisconsin Judicial Council minutes and archives.

Lawyers for Learners

The Wisconsin State Law Library promotes these legal services to users throughout the state and is a partner of the program. Lawyers for Learners' goal is to help people overcome legal obstacles, empowering them to move forward with their lives and achieve their educational and career goals.
