- 1) Roll Call and approval of the Minutes from November 17, 2023.
- 2) As is clear from the November 17, 2023 Minutes which accompany this Agenda, the November 17<sup>th</sup> meeting was cut short when Chair Gleisner inadvertently disconnected the telephone participants in that meeting. As he said then, Attorney Gleisner sincerely regrets this mistake. When the November 17, 2023 meeting ended the Council was discussing the composition and future of the Judicial Council's *DAR Recording Ad Hoc Committee*. As a reminder, the two co-chairs of that Committee are Judges Dugan and Gasiorkiewicz. We begin this meeting with a Report from Co-Chair Dugan.
  - **A)** In her Report, it is anticipated that Judge Dugan will touch on a number of issues, including suggestions made by Justice Hagedorn, contacts made by the Co-Chairs of the Ad Hoc Committee with Chief Judge Jason A. Rossell, Committee Chair of the Committee of Chief Judges, and efforts to coordinate with the current and former Directors of State Courts.
  - **B)** Judge Dugan will also discuss the composition of the Ad Hoc Committee, and its relationship to the Council's Criminal Procedure Committee.
  - C) Judge Dugan will also confirm the present members of the Ad Hoc Committee, such as Council Members, Gleisner, Kilpatrick, Plotkin and Zylstra and accept suggestions for other members.
  - **D)** It is expected that Judge Dugan will touch on a number of other issues, including some or all of the following:

- i) Updates on communications about DAR Recording Rules.
- ii) Brainstorming regarding:
  - (1) Concerns regarding the current process of handling DAR recordings.
  - (2) Ideas for future processes.
  - (3) Rulemaking approach and limitations.
  - (4) Legislative approach and limitations.
  - (5) Two-pronged approach; some concerns addressed by legislative and some concerns addressed by rule making.
  - (6) Supreme Court's Making the Record Committee minutes review.
  - (7) Plan for Review of Districts' current policies/procedures.
- iii) It is also anticipated that Judge Dugan will also discuss in her Report how the Council can and should interact with other committees, authorities and other interested parties who are investigating how best to address the challenges of the DAR Recording phenomena.
- **E)** It is anticipated that during and especially after Judge Dugan's Report, there will be a discussion by the Council of points raised by Judge Dugan in her Report.
- **F)** As I mentioned at the last meeting, I spent two days at the Prosser State Law Library researching the issue of DAR and related technologies. I retrieved a number of interesting research materials from the Library. I am again supplying several items with this Agenda which may be consulted during the discussion which will follow Judge Dugan's report.
