**MINUTES OF THE MEETING OF THE
WISCONSIN JUDICIAL COUNCIL
MADISON, WISCONSIN
June 24, 2022**

The Judicial Council met at 9:30 a.m. on June 24, 2022 in the Senate Parlor at the Capitol.

A social meeting was conducted for just under two hours. During the Social Meeting, an Award was presented to Senator Van Wanggaard, which read in part as follows: “In Recognition of Ten Years of Service and Outstanding Support for the Work and Values of the Judicial Council.”

A business meeting was thereafter held and the following business was transacted. First, the minutes of the May 20, 2022 were approved. Second, the Council heard from the Council’s 2022 Nominating Committee consisting of Judges Dugan, Gasiorkiewicz, Hruz, Needham and VanDeHey. Chair of the Nominating Committee, Judge Gasiorkiewicz, reported that the Committee had nominated Gleisner and Orton for Chair and Vice Chair. Hearing no nominations from the Floor, the Council voted unanimously to re-elect William Gleisner as Chair of the Council and John Orton as Vice Chair of the Council.

There was further discussion regarding meetings for 2022 to 2023. It was decided by consensus that full Council meetings by Zoom would henceforth be eliminated except where an emergency (such as the weather) prevented in-person meetings. It was further decided by consensus that at in-person meetings in the future, remote attendance could be accommodated by phone. If a member wished to attend an in-person meeting via Zoom at least two weeks notice would have to be given to the Council Chair.
