NOTICE OF OPEN/CLOSED MEETING FOR  
PURPOSES OF INTERVIEWING CANDIDATES FOR EMPLOYMENT**

Notice is hereby given of a Special Meeting of the Council's Executive Committee which will take place on November 17, 2025 beginning at 2 p.m. at the Offices of Foley & Lardner, 777 East Wisconsin Avenue, Milwaukee, 40<sup>th</sup> Floor.

**OPEN AND CLOSED AGENDA**

At 2 p.m., November 17, 2025, the Executive Committee of the Wisconsin Judicial Council will convene at the 40<sup>th</sup> Floor Reception Area of Foley & Lardner, at 777 East Wisconsin Avenue, in Milwaukee. The sole purpose of this Meeting will be to interview four candidates for the position of Staff Attorney to the Judicial Council and to confer and decide on a choice of a candidate to recommend to the Council.

The Judicial Council Executive/Selection Committee will convene in open session on November 17, 2025 in the Reception Area on the 40<sup>th</sup> floor of Foley & Lardner at 777 East Wisconsin Avenue, Milwaukee and will immediately move to a closed session pursuant to Wis. Stat. § 19.85(1)(c). In interpreting that section, the Wisconsin Attorney General has provided the following opinion in his March, 2025 *Wisconsin Open Meetings Law Compliance Guide* at p. 27:

[This] exemption [in Wis. Stat. §19.85(1)(c)] ... relates to employment matters [and] authorizes a closed session for '[c]onsidering employment, promotion, compensation or performance evaluation data of any public employee over which the governmental body has jurisdiction or exercises responsibility... The Attorney General's Office has ... concluded that this exemption is sufficiently broad to authorize convening in closed session to interview and consider applicants for positions of employment.'

Following the Interviews and a decision on a choice of a candidate, the Judicial Council Executive/Selection Committee will then reconvene into open session prior to adjournment of this meeting. This notice is intended to inform the public that this meeting will convene in open session, may move to closed session, and then may reconvene in open session. The specific Agenda is as follows:

2:00 p.m. Roll call.

2:05 p.m. Motion to reconvene in closed session to interview four applicants and decide on a final candidate to recommend to the Judicial Council.

At a time to be determined: Reconvene into open session prior to adjournment.

**PUBLIC NOTICE**
