Every Tuesday morning from 9 to 11 a.m., a volunteer attorney from the Dane County Bar Association is available to assist people with questions, forms, and procedures regarding Small Claims actions, including money judgments for under \$5000, garnishments, and evictions. No legal advice is given.
